Agenda 1. Selection of Research Supervisors.

It was resolved that the prospective guides shall apply to the Dy. Registrar for recognition as Research supervisor for M.Phil/Ph.D. programme. After examining the applications, this Board will send its recommendation to the Honorable Provost for approval of supervisorship. The next meeting for scrutinization of application form of prospective guide was proposed on 29.09.18 and approved by the members.

Agenda 2. Criteria for selection of Supervisors for M.Phil. & PhD programme

It was resolved that only a full time regular teachers of the Atmiya University can act as a Supervisor. The External Supervisors are not allowed.

After discussion, following eligibility criteria were set for supervisorship:

2.1 M.Phil. supervisorship:

2.1.1 The candidate should be a permanent faculty of the Atmiya University and should holds the degree of Ph.D. with 8 years of Under graduate OR 2 Years post-graduate teaching experience on regular/permanent basis in a recognized Higher Educational Institute (HEI), with 2 publication in the journal of national/international repute notified by UGC/NAAS.

- 2.1.2 The candidate should be a permanent faculty of the Atmiya University and should hold the degree of Ph.D. plus Three years research experience (excluding his Ph.D. research period) in a recognized HEI/Research Center.
- 2.1.3 M.Phil. Research Supervisorship shall not be granted to the teachers working as Guest Lecturers / Teaching Assistants/ or Visiting Professor.
- 2.1.4 Any supervisor is not allowed to enroll a candidate for M.Phil. degree who is in close blood relation with him/her.

2.2 Ph.D . Supervisorship:

2.2.1 The candidate should be a permanent faculty of the Atmiya University and should hold the degree of Ph.D. plus five years post-graduate Or 10 Years of undergraduate teaching experience on regular/permanent basis in a recognized Higher Educational Institute (HEI).

2.2.2 The candidate should be a permanent faculty of the Atmiya University and should hold the degree of Ph.D. plus five years research experience (excluding his Ph.D. research period) in a recognized HEI/Research Center.

- **2.2.3** The candidate should have published at least five (5) publications in the journal of national/international repute notified by UGC/NAAS.
- 2.2.4 In case of interdisciplinary research work, a Co-Supervisor may be appointed in consultation with supervisor concerned by URAB. Co-Supervisor can be allowed in inter-disciplinary areas from same/other departments of the Atmiya University or from other related institutions with the approval of the University Research Advisory Board (URAB).
- 2.2.5 Only one candidate may be registered as Co-supervisor under a Supervisor in addition to his/her limit of registered candidates.
- 2.2.5. The above be effective from AY 2018-19 and onwards

Agenda 3. Policy for Full Time and Part Time PhD research scholars

It was proposed that Atmiya University will admit the following categories of students in M.Phil. and Ph.D. programmes:

3.1 FULL-TIME RESEARCH SCHOLARS (For M.Phil and Ph.D. candidates)

Candidates who pursue their Full-time research leading to M.Phil. and Ph.D. degree under the guidance of a Research Supervisor.

3.2 INTERNAL-PART-TIME RESEARCH SCHOLARS (For Ph.D. candidates)

Candidates who are presently employed either Regular or Temporary basis with a minimum of two year of continuous service at Atmiya University are also allowed to pursue their doctoral research under the guidance of a Research Supervisor on Internal - Part time basis. The University Research Advisory Board will select the internal Ph.D. candidates every year based on the norms of the university. Internal-part time research scholars selection will be made by the registrar and will be approved by the president.

Agenda 4. Provision of conversion of full time PhD scholar to Research Assistance or Research Associate as per the UGC/DBT/DST schemes

It was resolved that:

- 4.1 Atmiya University may permit to convert from Full-time to Part-time research or vice-versa in respect of registered Ph.D. candidates for valid reasons with subject to satisfying the regulations in force and the approval of the Provost. The minimum and maximum period of research will be decided on pro-rata basis, based on the period already completed in Full-time / Part-time category.
- 4.2 The conversion is allowed only once during the complete period of research by paying the prescribed fee
- 4.3 Those students who have already completed the 60 % period under Fulltime or Part-time category are not eligible for conversion.
- 4.4. The above be effective from AY 2018-19 and onwards

Agenda 5. Process of Appointment of PhD & M Phil Scholars

Following was resolved:

5.1 The University shall admit M.Phil (Full-time) / Ph.D. (both Full Time and Part Time) students through an Entrance Test (i.e. Atmiya University M.Phil/Ph.D. Entrance Test i.e. AUMPET)

5.2 The Atmiya University will:

- **5.2.1** decide on an annual basis through their academic bodies a **predetermined** and manageable number of M.Phil/Ph.D. scholars to be admitted depending on the number of available Research Supervisors and other academic and physical facilities available, keeping in mind the norms regarding the scholar-teacher ratio and laboratory, library and such other facilities;
- **5.2.2** notify well in advance in the University website and through wide circulation, the number of seats for admission, subject/discipline-wise distribution of available seats, criteria for admission, procedure for admission, examination centre(s) where entrance test(s) shall be conducted and all other relevant information for the benefit of the candidates; adhere to the National/State-level reservation policy, as applicable.
- 5.3 The admission will be based on the criteria notified by the University, keeping in view the guidelines/norms in this regard issued by the UGC and other statutory bodies concerned.

5.4 The Atmiya University will admit candidates by a two stage process through:

5.4.1 The Entrance Test (AUMPET) shall be qualifying test for admission with qualifying marks as 50%. The syllabus of the **AUMPET** shall consist of 50% of research methodology and 50% shall be subject specific.

5.4.1.1 Entrance Test (AUMPET) Syllabus:

- · Research Methodology (50%) Syllabus shall be prepared by concerned Department
- Subject Specific (50%) As per syllabus of paper II of *UGC NET/CSIR NET examination in concerned subject

(*In those subjects where UGC/CSIR NET examinations are not conducted, University Research Advisory Board of respective subject will design the syllabus)

5.4.1.2 A candidate, who seeks admission to Ph.D. programme under Foreign/NRI category, is exempted from the written test however they have to appear before the interview committee with their research proposal.

5.4.1.3 For admission to Ph.D. programme the candidates who have qualified M.Phil. / CSIR-NET / UGC-NET / ICAR / SET examinations, candidates working in the sponsored research projects and FIP candidates, candidates with fellowship in MHRD / RGNF / CSIR / DST / ICSSR etc, and the internal teacher candidates will be exempted from the written test.

5.5 The above be effective from AY 2018-19 and onwards

The lack of an encouraging academic environment, ill-equipped libraries, labs and equipment, inadequate infrastructure, lack of funds, faculty crunch, etc, are some of the factors contributing to the dismal picture of research in Indian academic institutions. In agreement with Hon. Prochancellor madam, he also supported that such scheme will definitely bring significant changes in our university.

General comments by other members

Dr. Sheela Ramachandran, Prochancellor of Atmiya University stressed that in a globalized world, the role of research in an academic institution is significant for its sustainability and development, and it is imperative to have knowledge-driven growth based on innovation. Atmiya University Seed Money Financial Assistance Programme – 2021 is definitely a step towards this direction and cultivate a culture of research and innovation at Atmiya University.

Prof. Datta Madamwar, Expert member and Research Advisor of Atmiya University, suggested that in science and engineering discipline, it is quite difficult to do a quality project in limited time span & fund, hence he suggested that duration of project, particularly for science and engineering discipline, should be at least for two years and seed amount should also be increased to 2.5 lac for these disciplines.

Since this is the first time implementation of the scheme at AU, committee deferred it for current phase and decided to discuss the same in subsequent meeting for consideration in next phase after reviewing the outcome of first phase.

Dr. D.D. Vyas, Dean Transformative, Atmiya University, suggested that the Atmiya University being a newly established University is still in its infancy stage particularly in research progression and outcome. To promote the research and motivate the faculties and students in doing research in identified areas, along with the seed-money projects scheme, some other activities (like FDPs/Workshops/Hands on Training/Webinars etc.) needs to be conducted in up-coming session.

The Chairperson assured that the URAB will plan and execute such type of activities in upcoming sessions.
